## Exhibit A to Articles of Incorporation for Campbell Courte Condominium Association, an Illinois not for profit corporation

#### Article 4.

The purposes for which this corporation is organized are:

- (a) To engage in the administration, maintenance and improvement of the Common Elements (including but not limited to Limited Common Elements) of the Campbell Courte at Village Green Condominiums, as permitted under the General Not-For-Profit Corporation Act.
- (b) To act on behalf of its members collectively, as their governing body, with respect to the preservation, care, maintenance, replacement, improvement, enhancement, operation, architectural control and administration of both real and personal property for the promotion of the health, safety, and welfare, and the common use and enjoyment, of said Common Elements, as more fully set forth in the Declaration of Campbell Courte at Village Green Condominiums as recorded in Cook County, Illinois (the "Declaration").

#### Article 5. "Other Provisions":

Until the first (turnover) meeting of the Owners, the Board of Directors shall consist of three (3) persons designated by the Declarant under the Declaration. From and after that meeting, the board of Directors shall consist of the number of persons and provided for in the Declaration and the By-Laws of this corporation.
