This document is recorded for the purpose of amending the Declaration of Condominium Ownership (hereafter the "Declaration") for the Campbell Courte at Village Green Condominium Association, (hereafter the "Association"), which Declaration was recorded on July 31, 2000 as Document Number 00577253 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Section 9.02 of Article Nine of the aforesaid Declaration. Said section provides that the Declaration may be amended by an instrument in writing approved by no less than seventy-five percent (75%) of the unit owners. No amendment is effective until recorded.

In addition, the consent of sixty-seven percent (67%) of all First Mortgagees holding first mortgages on units is required pursuant to Article Ten, Section 10.02(a)(i)(ix). The consent of a First Mortgagee shall be deemed granted unless advised to the contrary in writing within 60 days after the mailing of a consent by Certified Mail, return receipt requested. Finally, Article Nine, Section 9.03 provides that a copy of any amendment must be mailed to the Village of Arlington Heights.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the covenants contained therein; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

WHEREAS, the following Amendment has been approved by at least seventy-five percent (75%) of the Unit Owners as evidenced by the approvals attached hereto; and

WHEREAS, an affidavit is attached hereto as Exhibit C certifying that the Mortgagees have been notified by certified mail and approved of this Amendment and contained in the mailing was a consent form in the format attached hereto as Exhibit D; and

WHEREAS, an affidavit is attached hereto as Exhibit E certifying that a copy of this Amendment has been mailed to the Village; and

NOW, THEREFORE, the Association hereby declares that the Declaration be and is hereby amended as follows (additions to text are shown as double underlined and deletions to text are shown as a ~~strikeout~~):

1. **Article Three, Section 3.17 of the Declaration shall be deleted and replaced with the following:**

3.17 Leasing of a Unit: No Unit shall be leased by a Unit Owner for hotel or transient purposes or for a term less than six (6) months and no portion of a Unit which is less than the entire Unit shall be leased. Each lease of any one or more Units shall be in writing. The lessee under every such lease shall be bound by and subject to all of the obligations, under the Declaration and By-Laws, of the Unit Owner making such lease and the failure of the lessee to comply therewith shall constitute a default under the lease which shall be enforceable by the Board or the Association, and the lease shall be deemed to expressly so provide. The Unit Owner making such lease shall not be relieved thereby from any of said obligations.

Notwithstanding any foregoing provisions of this Declaration to the contrary, effective with the recording of this Amendment, the following provisions shall apply:

(a) Any Owner that has acquired their Unit after the effective date of the recording of this Amendment, desiring to lease out their Unit must have owned and occupied their Unit for a minimum of two (2) years to be eligible to lease their Unit.

(b) The Unit Owner must apply to the Board prior to entering into a lease agreement and provide a copy of the proposed lease. The Board shall promptly review the proposed lease agreement in order to verify that it complies with the standards as set forth herein.

(c) Hardship Exemption or Job Move Exception. To meet special situations and to avoid undue hardship or practical difficulties, the Board may, but is not required to, grant permission to lease to Unit Owners that have owned the Unit for less than 2 years, such as is if an owner is transferred outside of the immediate area ("job move exception"), which will allow the leasing of the Unit for up to 2 years with approval from

the Board, which will not be unduly restricted providing the Unit Owner provides documentation of the job move. The period that a unit owner is renting due to a job move exception will not count as time towards the minimum two year owner occupancy period. A unit owner cannot extend the job move exception beyond the two year period of time, nor can a unit owner have more than one job move exception within a 5 year period of time. Such permission for Hardship Exemption or Job Move Exception may be granted by the Board only upon written application by the Unit Owner to the Board. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. All requests for extension of the original lease must also be submitted to the Board in the same manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Unit Owner's application for a lease or extension of a lease. The Board's decision shall be final and binding. Any lease approved by the Board shall be subject to the Declaration, By-Laws and rules and regulations governing the Association.

(d) The Board of Managers of the Association shall have the right to lease any Association owned Units or any Unit which the Association has possession, pursuant to any court order, and said Units shall not be subject to this Amendment.

(e) Any Unit being leased out in violation of this Amendment or any Unit Owner found to be in violation of the Rules and Regulations adopted by the Board of Managers may be subject to a flat or daily fine to be determined by the Board of Managers upon notice and an opportunity to be heard.

(f) In addition to the authority to levy fines against the Unit Owner for violation of this Amendment or any other provision of the Declaration, By-Laws or Rules and Regulations, the Board shall have all rights and remedies, including but not limited to the right to maintain an action for possession against the Unit Owner and/or tenant, under 735 ILCS 5/9 et. seq., an action for injunctive and other equitable relief, or an action at law for damages.

(g) Any action brought on behalf of the Association and/or the Board of Managers to enforce this Amendment shall subject the Unit Owner to the payment of all costs and attorneys' fees at the time they are incurred by the Association.

(h) All unpaid charges as a result of the foregoing shall be deemed to be a lien against the Unit and collectible as any other unpaid regular or special assessment, including late fees and interest on the unpaid balance.

2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

3. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.

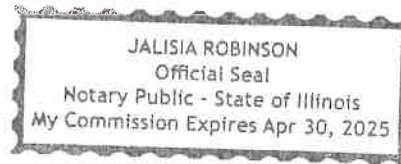

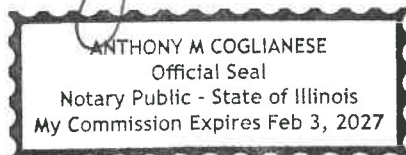


