# 1. Moving In & Out

- a. A \$500 deposit shall be due to the Association by any Owner prior to moving in or out of the community. The deposit shall be returned within 30 days of the move, following confirmation that no damage was caused. Any and all damages caused by the Owner's movers, delivery carriers, contractors, and guests remain the sole responsibility of the Owner. (Allowing a \$500 charge on the account as an alternative to a cash deposit).
- b. Semi tractors with trailers are not permitted within the development. Box trucks or smaller vehicles must be used due to the limited size of the roadway.

# 2. Holiday Lights

a. Holiday lights/decorations may be up/on no earlier than Nov 15<sup>th</sup>, off by Jan 15<sup>th</sup> and down April 1<sup>st</sup>

### 3. Storm/Screen Doors

- a. The door frame must match building trim, hardware must match door hardware

# 4. Landscape Responsibility

a. All landscaping is ultimately the responsibility of the HOA. The Board understands some Owners may wish to enhance the landscaping immediately adjoining their lot. Owners that wish to add to or enhance their landscaping within the confines of existing landscaping beds adjoining their lost must obtain written approval from the HOA and accept responsibility for replacements and excess maintenance for all enhancements.

# 5. Dog Leash

a. All pets are required to be on a leash attended by a responsible handler when outside of the home. Any violation of this provision shall be subject to a written warning, a \$250 fine for the second occurrence, and a \$500 fine for any occurrence thereafter.

# 6. No Fishing

a. Access to and any use of the pond is strictly prohibited. Any violation of this provision shall be subject to a written warning, a \$250 fine for the second occurrence, and a \$500 fine for any occurrence thereafter.

## 7. Restricted Access to the Pond and the Native Buffer

a. All native areas, tree preservation areas, and do-not-disturb areas shall not be disturbed. Any maintenance work shall be done by association contractors or have prior approval from the Board. Any violation of this provision shall be subject to a written warning, a \$250 fine for the second occurrence, and a \$500 fine for any occurrence thereafter.

# 8. Yard Signs and Banners

- a. Upon 24 hours' notice, and without compensation to the Homeowner, the Association may remove any yard sign or banner in the following circumstances:
  - i. If the sign or banner does not conform to this policy or has not been approved by the Association

- ii. At expiration of the approved display period
- iii. If the yard sign or banner is deemed to be in disrepair
- iv. If the content is deemed to be offensive by a majority of the Board Members
- b. Approved and Prohibited Yard Signs and Banners
  - i. Yard signs and banners conforming to the specifications in the Approved Yard Signs and the Approved Banners charts on page following, **need not** be submitted to the Association for approval.
  - ii. A yard sign or banner not automatically approved per the paragraph above, must be submitted to the Association's Board of Directors for Approval.
- c. Individual Homeowner's Responsibilities
  - i. The Homeowner's responsibilities include:
    - 1. Ensuring that the approved sign or banner is constructed of durable, weather-resistant materials
    - 2. Ensure that the approved sign or banner is secured with windproof mountings
    - 3. Displaying only the prescribed number of sings or banners at any one time
    - 4. Removing the sign promptly upon expiration of the authorized display period
