

# SWIMMING POOL

Swimming permitted ONLY when attendants are on duty!

Absolutely NO swimming before or after hours!

The pool will open the weekend of Memorial Day, weather permitting, and will be kept open through Labor Day.

## HOURS OF USE:

Daily      10:00 a.m. to 8:00 p.m. Monday through Friday or as posted  
              9:00 a.m. to 8:00 p.m. Saturday and Sunday or as posted

Abbreviated hours (see posting at pool house) may be used when public schools are in session during the months of May/June and August/September.

The pool will be closed when the temperature drops below 68 degrees, if it is raining, if there is a lightning storm, or there is any other type of potentially harmful weather.

**THE POOL ATTENDANT ON DUTY IS THE SOLE AUTHORITY IN ADMINISTRATING THE POOLS AND THE RULES & REGULATIONS PERTAINING TO THE POOLS AND POOL AREAS AND IS AUTHORIZED TO CALL THE POLICE IF NECESSARY TO ENFORCE RULES.**

The pool attendant has authority to REMOVE any person(s) who break(s) ANY Rule or Regulation. The pool attendant may call timeouts/swim breaks at his/her discretion.

## Definitions:

- a. **Adult** shall be defined as any person 16 years of age or older.
  - b. **Owner/resident** shall be defined as any individual holding fee simple absolute title to a unit at Sandpebble, or the beneficiary of a trust holding fee simple absolute title to a unit at Sandpebble, or a lessee of a unit owner holding fee simple absolute title to a unit at Sandpebble.
  - c. **Guest** shall be defined as any individual allowed access to the pool area upon permission of an owner or resident as defined by these rules. **NO GUESTS ARE ALLOWED IN THE POOL AREA UNLESS ACCOMPANIED BY THE UNIT OWNER/RESIDENT.**
1. Everyone, age 5 or above, must present the attendant a Sandpebble Walk **Pool ID Pass** or a Sandpebble Walk **Pool Guest Pass**. **Anyone over the age of 16 and a resident of Sandpebble Walk will also be required to present an Illinois State Driver's License, or Illinois State ID containing a Sandpebble Walk address. Caregiver/Nanny and Off-site owners need to show an Illinois State Driver's License or Illinois State ID but the address does not need to be a Sandpebble Walk address.** Everyone must sign in when entering the pool area and sign out when they leave the pool area for the day. New Owners may contact the Management Agent as listed at the end of this booklet for I.D. passes. Lost I.D. or guest cards may be replaced at a charge of \$15.00 per card. Damaged cards can be replaced at a charge of \$5.00 per card, provided, the damaged card(s) is/are returned. Fees are subject to change without notice. Contact the Management Agent as listed at the end of this booklet for replacements.

- a. Only currently issued Pool ID passes and Guest Passes will be accepted.
  - b. ID passes will be issued to owner or resident with a **completed form and a current State of Illinois Driver's License, or State of Illinois ID containing a Sandpebble Walk address. If an off-site owner wishes a Pool ID pass, proof of ownership must be provided.**
  - c. **Permanent caregivers** may be allowed ID passes. The registration form (Exhibit E) must be completed by the homeowner/resident. Issuance is at the discretion of the Board of Directors of the Sandpebble Walk Homeowners Association. Caregiver ID passes must be renewed every year.
  - d. **Guest Passes must be obtained from the seller.** New Guest passes will be supplied at \$15.00 per pass.
2. The **attendants/guards are in complete charge** of the pool areas and have the authority to enforce the rules in all matters of conduct, attire and admission. **Should a Sandpebble resident observe any breach of these rules or unsafe conduct in the pool area, it is the responsibility of the resident to report the violation to the lifeguard.** The lifeguard will make the final decision as to what course of action will be taken. Should a Sandpebble resident observe a person(s) swimming or on the pool deck when the pool is closed, the resident should call the Wheeling Police (911) immediately to report the incident.
  3. All persons using the swimming pool facilities do so at their **own risk**, and the Sandpebble Walk Homeowners Association assumes no responsibility for any illness, accident or injury suffered by any person in either of the swimming pools or in the general areas.
  4. Adult unit owners/residents may invite up to (4) guests to enjoy pool facilities. The unit owner/resident must accompany any guests. **GUESTS ARE NOT ALLOWED IN THE POOL AREA UNLESS ACCOMPANIED BY THE UNIT OWNER/RESIDENT NOR WILL BE ALLOWED TO REMAIN IF THE UNIT OWNER/RESIDENT WHO BROUGHT THEM INTO THE POOL AREA LEAVES THE POOL AREA.**
  5. **Hair** that exceeds shoulder length must be restrained.
  6. All individuals using the pool must take a **soap shower** before entering the deck area. All tanning agents must be removed by showering before re-entering the pool EACH TIME tanning agent is applied.
  7. Persons must remove **street shoes** of any kind upon entering the pool areas or deck. No street shoes allowed in "wet" areas of the bathhouses. Proper swim attire is required: No cut-offs or any type of street clothing is allowed in the pool. No thongs of any type (the buttocks area must be covered) are allowed in the pool or pool area. Tee shirts for sun protection may be worn at the discretion of the lifeguards.
  8. Persons with open sores or skin diseases are not allowed in pool or pool area.
  9. No child **under 16 years of age** shall be admitted or remain at the pool area unless accompanied by an adult owner/resident. Children 16 and older will need to provide a birth certificate or school ID indicating their date of birth or age.
  10. Children 15 years of age and younger **must use the North Pool.** Children 5 years of age and younger **must be accompanied** in the water by an adult.

11. **All children NOT "TOILET" TRAINED must be in swim diapers.** The homeowner will be held financially responsible for recycling the pools in the event their child or their guest's child pollutes the pool. All children 5 years or younger must be accompanied to the washrooms by an adult. **Diapers** are to be changed inside the washroom and not on the pool deck. Children not properly covered will not be allowed in the pool area. Children with diarrhea are not permitted in the pool at any time. All children over the age of 5 must use gender appropriate washrooms.
12. No pets are allowed anywhere in the pool area. No bicycles, **buggies, strollers**, skates or other objects with wheels shall be allowed in pool area. Handicap equipment with wheels is exempt.
13. **No food, alcohol, fruit juices, soda or other beverages shall be permitted in the general pool area or deck. This includes, but is not limited to cookies, crackers, juice boxes, fruits (i.e. grapes, cherries, oranges or orange segments, etc.) or vegetables.** Water may be obtained from the drinking fountain in the pool deck area or in one of the washrooms. Food and beverages may be consumed outside the pool area in the picnic/patio area. The lifeguard must be on duty at all times and therefore is permitted to eat and drink in the pool area. Water contained in clear plastic bottles will be permitted on the pool deck on a **probationary** basis. If abuse occurs, the Board reserves the right to **immediately** revoke the privilege of allowing water in plastic bottles on the pool deck.
  - a. Chewing gum is not permitted in the pool area or on the pool deck. Gum must be properly disposed of before entering the pool house.
14. **No glass containers** of any kind are permitted in the pool area.
15. Inflatable rubber or plastic swimming floats may be used in the North Pool with the approval of the lifeguard. These devices are NOT allowed in the South Pool at any time. **An adult must accompany a child using floats, into the water and be within arm's reach of the child at all times.**
16. The only toys allowed in the pool areas must be pool appropriate and are only allowed in the North pool area. **Motorized toys, squirt guns, or water games (including but not limited to volley ball and water polo) are not allowed.**
17. Towels, bathing suits/trunks and robes **shall not be hung over the fences**, but shall be confined to the chairs or lounges.
18. **Radios may only be used with headphones.**
19. Chairs and pool facilities are paid for by your assessments. Please use them properly. There shall be **no reservation** of chairs for anyone who is not in attendance at the pool. Because of the limited supply of chairs, unit owners may bring their own chairs or lounges. We encourage residents who are bringing guests to the pool to bring their own chairs or lounges.
20. **No lounges** are permitted under canopies on Saturdays, Sundays and Holidays. Lounges may be permitted under canopies on weekdays at the lifeguard's discretion.
21. Personal conduct should not jeopardize safety nor infringe on the enjoyment of the pool facilities by others. Examples of **behaviors not allowed** include running, fighting, pushing, screaming, dunking, climbing and boisterous or rough play. **No abusive language will be tolerated.**

22. Loud and/or obnoxious cell phone usage is not permitted. Cell phone usage should not disturb others at the pool.
23. **Diving is not permitted.**
24. **Smoking is not allowed anywhere within the fences of the swimming pool area, in the washrooms, by the entrance to the pool house or near the picnic tables.** If you wish to smoke you will have to leave this area. Please do not litter the parking area with cigarette butts. This may result in a fine.
  - a. E-cigarette smoking is not allowed inside the pool area or on the pool deck.
25. **Violations** of these Pool Rules or such others as may be added or amended thereto, shall be sufficient reason for suspension of pool privileges. It is hoped such action will not be necessary, but in the event that such action is required, the offending unit owner/resident shall be given the opportunity to be heard by the Sandpebble Walk Homeowners Association Board of Directors prior to such suspension. A special meeting of the HOA Board of Directors may be called for such hearing. Notice for such hearing may be as short as two days.
26. These rules are in addition to all State and Local Statutes and Ordinances in respect to conduct of individuals at swimming pools AND indecent behavior laws.

## **SWIMMING POOL PATIO/PICNIC AREA**

1. No cooking or barbecuing or smoking allowed.
2. Limit your group to the use of one table.
3. Individuals are limited to one (1) hour per table.
4. Individuals are responsible to clean up after using the picnic area.
5. Individuals are prohibited from leaving any personal items on the picnic tables for any purpose including reserving said tables.
