NOW THEREFORE, Section 14 of Article XII of the Declaration is deleted in its entirety and is replaced with the following:

Section 14. Pools, Jacuzzis and Hot Tubs.

Owners are permitted to install in-ground or permanent above-ground pools. Owners are permitted to install outdoor Jacuzzis and hot tubs included within a deck or patio provided that such Jacuzzis and hot tubs are screened from view from neighboring lots. Pools, Jacuzzis and Hot Tubs must be installed in accordance with all applicable laws and with the prior written approval of the Board.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Kane County, Illinois.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.




