"...The Association shall be responsible for the proper maintenance of all landscaping located on the Common Area and Single Family Units including, but not limited to, mowing the grass areas. However, the Owners shall be responsible for snowplowing and ice removal of all parking areas and sidewalks serving their Single Family Units."

- 2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Lake County, Illinois.
- 3. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.


